I submit my report as under:

1. The remote e-voting period remained open from 9.00 A.M. IST on Friday, the 20<sup>th</sup> November, 2020 up to 5.00 P.M. IST on Tuesday, the 24<sup>th</sup> November, 2020.
2. The Shareholders holding shares as on the “cut off” date, i.e. 16<sup>th</sup> November, 2020 were entitled to vote on the proposed 3 (Three) resolutions as mentioned in the Notice dated 29<sup>th</sup> October, 2020 of the Annual General Meeting of the Company.
3. The Company has also distributed the physical ballot forms at the venue of the Annual General Meeting to enable the shareholders to cast the votes physically in case the same has not been cast by them through remote e-voting.
4. The locked ballot box was subsequently opened in my presence and poll/ballot papers were diligently scrutinized. The poll/ballot papers were reconciled with the records maintained by the Registrar and Share Transfer Agents of the Company and the authorizations/ proxies lodged with the Company.
5. The votes were unblocked on Wednesday, the 25<sup>th</sup> November, 2020 around 01:20 P.M. after the completion of the Annual General Meeting in the presence of two witnesses, namely, Mr. Narayan Chandra Saha, residing at 40, Weston Street, 3rd Floor, Kolkata – 700013 and Ms. Nidhi Bansal, residing at 62, Vijay Kumar Mukherjee Road, Salkia, Howrah – 711106, who are not in employment of the Company.

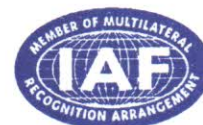

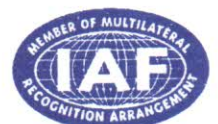
